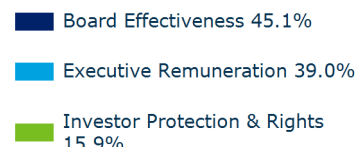

Social topics featured in 29.1% of our engagements



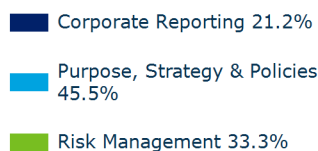
Governance
