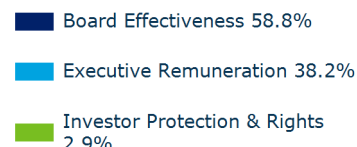

Social topics featured in 17.3% of our engagements



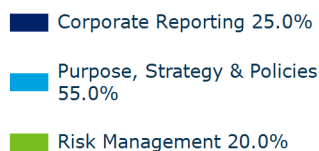
