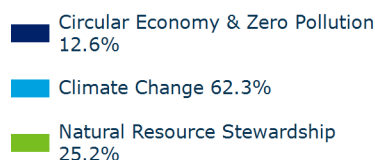

Environmental topics featured in 35.7% of our engagements



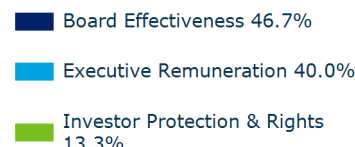
Social

Social topics featured in 31.2% of our engagements



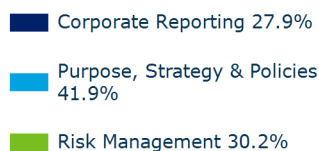
Governance
