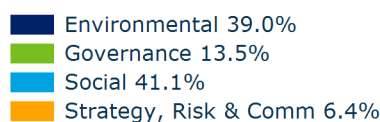

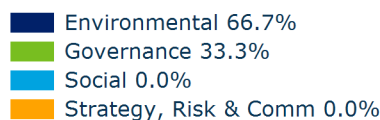

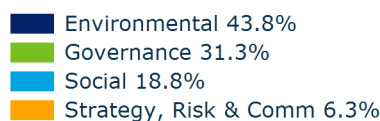

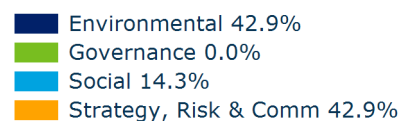

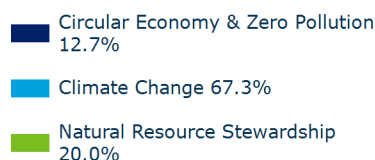

Environmental topics featured in 39.0% of our engagements



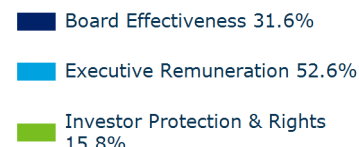
### Social
