He led the company for 20 years before entering public service full-time, and since leaving City Hall in 2013, has resumed leadership of Bloomberg LP.

Michael was elected mayor less than two months after the terrorist attacks of September 11, 2001. Under his leadership, the city rebounded faster and stronger than expected on issues ranging from education to health to economic development.

A lifelong philanthropist, Michael founded Bloomberg Philanthropies, which focuses on five main areas: public health, education, the environment, the arts, and government innovation. He also leads a number of bi-partisan coalitions on urgent issues, including climate change, illegal guns, immigration reform and infrastructure investment.

Michael was named Global Ambassador for Noncommunicable Diseases by the World Health Organization in 2016.

Michael graduated from Johns Hopkins University and Harvard Business School.

His leadership helped revitalize the American auto industry, reform the healthcare system and put the country on a course to a clean energy future – all while overseeing the longest stretch of job creation in American history.

Barack Obama and his wife, Michelle, are the proud parents of two daughters – Malia, 18, and Sasha, 15.
