FUND COMMENTARY

In the first quarter of 2018, the S&P 500® Index returned -0.76%. Large-cap equities underperformed small-cap equities, as measured by the S&P 600® Index, which returned 0.57% in the first quarter.

The top-performing sectors over this time period were information technology and consumer discretionary, returning 3.53% and 3.09%, respectively. Telecommunications services and consumer staples were the worst-performing sectors for the quarter, with returns of -7.48% and -7.12%, respectively.

The Stock Index Fund returned -0.79% for the quarter, which was in-line with the Fund's benchmark, the S&P 500® Index, which returned -0.76% for the quarter. U.S. equities in the first quarter of 2018 saw their first negative quarter since third quarter 2015. The S&P 500® Index started the quarter extremely strong extending the exuberance from Q4 2017 generated from the new tax reform. The excitement pushed the Index to new all-time highs in late January before volatility came back into the markets due to some surprising economic news followed by trade war speculation. Market participants decided it was time to take some gains off the table as there was a surprise in employment data for January, which propelled interest rates higher and heightened rhetoric from Washington on new trade tariffs threatening the current projections for global growth. The Federal Reserve did continue with their efforts to normalize rates with a 25 basis point (0.25%) hike in March bringing the target rate to 1.75%, hinting at two more hikes later in 2018, as well as a more aggressive path potentially for 2019. This confluence of events led to an increase in market skepticism and uncertainty around future growth, hindering equities on the whole.
