 accurate reporting incorporating differing levels of distributions and allowing
 individual family members to see their share of the pooled assets.

- We designed tailor-made performance reports to report at an aggregated level as well as an individual family member level, allowing each individual to see their individual wealth at the asset, income and distribution level.
